### **BPI MS Policy Terms and Conditions**

1. The Insurance Policy premium to BPI MS shall be paid through the enrolled credit card.
2. Charging of the Insurance Premium due against the enrolled credit card is based on the chosen terms, if any.
3. In case of failed charge payment for the enrolled premium, BPI MS will contact the cardholder to inform him/her of the unsuccessful attempt.
4. Cardholder is aware that the enrollment to this payment facility is active and in-force for the duration of the policy coverage.
5. In case of cancellation/expiration/termination of credit card, cardholder must enroll another credit card.  
Failure to enroll another credit card shall not give rise to any liability on the part of BPI MS if the policy is cancelled for non-payment.

### **Credit card Installment Terms and Conditions**

1. BPI MS credit card installment payment is open to a cardholder with good credit standing of the following cards:
  - BPI Credit Cards (Blue MasterCard, Gold MasterCard, Petron-BPI MasterCard, BPI WorldPerks MasterCard, BPI SkyMiles MasterCard, BPI SkyMiles Platinum MasterCard, BPI Amore Visa, BPI Amore Visa Platinum and Edge MasterCard)
  - HSBC Red MasterCard, HSBC Premier World MasterCard, HSBC Platinum Visa, HSBC Cash Back Visa, HSBC Visa
  - China Bank Prime MasterCard, China Bank Platinum MasterCard, and China Bank World MasterCard
  - BDO-issued Visa and MasterCard credit cards
2. Cardholder can avail of the 0% installment subject to the submission of the required forms and approval within the agreed turnaround time.
3. To avail of the products and services, cardholder must either:
  - Personally present his/her credit card to any BPI MS Insurance Corporation office and sign the charge slip when the transaction is approved; or
  - Fill out the Credit Card Payment Form and send it to the nearest BPI MS Sales Office.
4. The terms and conditions governing the issuance of BPI, BDO, HSBC and China Bank Credit Cards, and the reminders and other provisions contained in the card carrier, statement of account, charge slips and other documents or instruments, which are made an integral part hereof by reference, shall likewise be resorted to in instances where they are applicable.
